Qualification Criteria:

1	Valid Business license	Valid Business License
2	Bid Security	Not less than AFN 2,056,000/- (Afghanis Two Million Fifty-Six Thousand only) or USD 30,000/- (United States Dollars Thirty Thousand only), in the form of a bank guarantee or cash.
3	Bank Statement or credit line	Bank statement/unconditional line of credit, not to be less than AFN 25,700,000/- or USD 375,000/-.
4	Similar Experience	- At least One Similar Contract within the last ten (10) years with a value of not less than AFN 61,678,000/- or USD 900,000/-. OR - Two (2) Similar Contracts within the last ten (10) years with a total value of not less than AFN 102,797,000/- or USD 1,500,000/-.

Should any of the information / data submitted by the offeror in the documents be unclear and not substantiated by supporting documents, such information shall not be considered for evaluation.

- a) Offerors shall submit their Proposals in hardcopy at the location and address as described in the RFP Document. Electronic submission of the Bids **will NOT** be accepted.
- b) The Proposals will be opened on **September 17, 2025, at 02:00 PM – Kabul, Afghanistan Time** at Conference Room, FMIC in the presence of the Bidders' designated representatives who chooses to attend.
- c) The International Offerors may attend the Proposal Opening Session through the zoom link shared by the FMIC. The link will be shared on the Proposal Opening Day and Time.
- d) The FMIC will NOT consider any proposals that arrives after the deadline for submission of Proposals. Any proposal received after the deadline for submission of proposals shall be declared late, rejected, and returned unopened to the Offeror.
- e) The FMIC will not be responsible for any cost or expenses incurred by the Offerors in connection with the preparation and delivery of their proposals.
- f) Subject to the offeror's request, a pre-bid meeting will take place at least five (05) days before the bid closing meeting, NOT later than that.
