- a) Bidders shall submit their Bids in hard copy at the location and address as described in the Bid Document. Electronic submission of the Bids by Bidders will **NOT** be accepted.
- b) The Bids will be opened on <u>June 05, 2025, at 10:00 AM</u> at <u>Conference Room, Admin block, FMIC</u> in the presence of the Bidders' designated representatives who chooses to attend.
- c) The FMIC will NOT consider any bids that arrives after the deadline for submission of bids. Any bids received after the deadline for submission of bids shall be declared late, rejected, and returned unopened to the bidder.
- d) The FMIC will not be responsible for any cost or expenses incurred by Bidders in connection with the preparation and delivery of their bids.
- e) Suppliers who are interested to participate in this procurement shall bring the below documents with them to FMIC and receive the Bid Document:
  - i. Signed and stamped <u>Interest Letter</u> in the letter head of the company
  - ii. Signed and stamped <u>Introduction Letter</u> for the representative of the company who receives the Bid Document (No need for the president or vice president).
  - iii. Tazkira of the representative
  - iv. Stamp of the company
  - v. Update Business License
- f) Subject to the bidder's request, a pre-bid meeting will take place at least five (05) days before the bid closing meeting, NOT later than that.
