#### **Background:**

The French Medical Institute for Mothers and Children (FMIC) herein referred to as “FMIC” invites sealed bids in one envelope from eligible bidders for the Procurement and Supply of Sterile Surgical Packs.

Bidding will be conducted in accordance with FMIC’s Single-Stage - One-Envelope bidding procedure and is open to all Bidders. The specifications and other terms & conditions are reflected in the Bid Document, Ref # FMIC-26-01-SSP.

**Important Notes:**

- a) Bidders shall submit their Bids in hard copy at the location and address as described in the Bid Document. Electronic submission of the Bids by Bidders **will NOT** be accepted.
- b) The Bids will be opened on **February 12, 2026, at 02:00 PM (Afghanistan Time)** at Conference Room, Admin block, FMIC in the presence of the Bidders' designated representatives who chooses to attend.
- c) The FMIC will NOT consider any bids that arrive after the deadline for submission of bids. Any bids received after the deadline for submission of bids shall be declared late, rejected, and returned unopened to the bidder.
- d) The FMIC will not be responsible for any cost or expenses incurred by Bidders in connection with the preparation and delivery of their bids.
- e) Suppliers who are interested in participating in this procurement shall bring the below documents with them to FMIC and receive the Bid Document:
